


30 years of critical consciousness raising

Times

dear companions on the path, diverse and numerous as you are,

during this year CIL celebrates its thirtieth anniversary. When I address you on this occasion as companions on the path, then this is actually a reflection of a vast complex; viewing it takes us back to 1985.

From a biographical perspective, related to the lives of individuals, the date means that several people who were part of the founding are no longer alive, that others most of you belong to this group - have since grown out of the stage of young adulthood, and that still others had not even been born then, or were inkindergarten.

Seen in terms of technology, during this period with the electronic revolution we have entered into a phase of human development which has changed our entire work-processes, our leisure behavior and communication possibilities. Regarding this development, we know that there is no problem on earth that cannot be solved in the long term, according to the thought in the laboratories. But we also know that, without the immense strengthening of ethical consciousness among humans, this development holds dangers of unimaginable magnitude for life on the planet.

Geopolitically, considering the historical events in Germany and Europe, a retrospective over the last 30 years shows the end of the great system confrontation of the 20th century, together with the overcoming of the division of Germany and the increase of the political relevance of Europe. However, there was also the unchecked growth of the expropriation by global concerns of local and regional resources, especially those of countries of the South and the increasing exploitation of human beings and nature.

Throughout this time period, we in the CIL have dealt with questions which were shaped and reflected by the biographical and political contexts we have mentioned. We are presenting them here in this catalog for the first time, in an almost complete overview with headings:

SEDUCTIONS

Although in the mid 80s, under the influence of the peace movements, it was the military bases and the challenges of their civilian use that engaged us, shortly before the events of the political Turn in Germany, and the end of the Soviet Union, we were occupied with the search for traces of Fascism, together with our cooperation partners in the Philippines, the USA and South Africa. Especially our founding partners in NYC were very concerned about the developments in the USA, because in the 80s it was only the pressure from the Democrat-dominated congress that could restrain the positive stand of the Reagan administration to the Marcos dictatorship, the Apartheid regime and a pro-military invasion in Nicaragua.

'Fascism has seized and shaped the people in Germany from within, in a virtually liturgical manner'. After three years of concentration on the effects of religious fundamentalism on democratic processes, this finding aroused our interest, and we made our way to Nicaragua, where we found Sandinistas and counterrevolutionaries living side by side in poverty. A people deeply shaken in their hopes.

SUSTAINABILITY

In 1992, with the UNCED-Conference in Brazil, a "concept with a claim" to be a new paradigm appeared on the world stage: Sustainability as the interplay of ecology, social aspects, and economy. In the CIL we turned this concept upside down and inside out in the following years. Together with organizations in the social movements from the USA, the Philippines, South Africa, Nicaragua and Germany, we investigated the realities of this concept in communities, were active in the Agenda 21 process in Frankfurt- on-the-Main, met in Nicaragua to become acquainted with proposals for ecological living and economic perspectives, and later also in Germany in the Anna-Paulsen-Haus of the EKD in Gelnhausen for an analysis of the economic activity of women.

METHODOLOGY

The special feature of CIL, which developed not later than 1994 with the pedagogy of confrontation: methodical – didactic activity. The praxis of learning as a work of art.

HUMAN RIGHT

I have the impression that sustainability has led us gradually to the practice of dealing with human rights. They became tangible; they acquired faces and lost their abstraction. It was women in certain living situations, young and old people and what they thought of one another, and could learn; questions about needs in everyday life, which led us to Ghana.

NEIGHBORHOOD

Meanwhile the EU enlarged itself with the East European member nations at the beginning of the new century. This was the time in which a new task began for CIL with the reconciliation of the neighbors. We took hold and in the past years have met with organizations in Lithuania, Poland, Slovakia, Austria and Turkey - which has not yet joined -

and come closer to them. At present we have the bitter experience of the refusal of these countries to grant refugee status to people suffering great distress, but this fact changes nothing. Indeed the intensive acquaintance with others leads to a certain understanding of the desire to do business in one's own house. That this collides with other demands will lead to other experiences.

Last but not least. Inclusion as а further assumed paradigm. In 2012 we began working on its unfolding and multiplication. The result was the work with the migrants' organization KONE - Network for promoting communication in Frankfurt-on- the-Main and the Mboko Academy in Douala, Cameroon. How do you cooperate internationally? Can we learn that with you? That was the question. We accepted the task as a challenge and developed and tested a dialogical approach for the paradigm of Inclusion, and found the reciprocal gaze of illusion.

AND NOW:

Dear companions, now I say thank you for all the years, for every friendly and critical word. For all the signs of solidarity when it was a matter of presence and support for those in need. How often was I myself such a one in need. I close now with the reason for the Logo of CIL, which was given to us many years ago when were searching for a new logo by Frau Amata Neyer, then Prioress of the Carmelite Convent in Cologne:

Perhaps bread and fish. Then bread represents what is absolutely essential, fish that which already goes beyond.

Seduction — Dialogues about Armament, Fascism and Fundamentalism

Seduction – A concept that has many different facets and yet is quite clear in its totality. Power, influence and control in religion, state, and society were the central themes of the work. They are witness to the diversity of the themes, and at the same time are woven inseparably with each other.

"Multi-facetted, yet clear in totality" is a description which could also apply to the work of the CIL in the first years. In international dialogue with and between the peace movements in various countries and regions, the most varied seductions and attractions became visible. Thus fears of fascism were apparent, as was the distress of the poorest in search of stability, on the way to fundamentalism.

The effects of militarization or the theme of land rights presented new and deepening insights into the horrors and seductions which were emerging.




Impacts of US Military Bases on the Stationing Locations

The reader served as the contribution of the German delegation to the preparations for the meeting in the Philippines. It was the first draft of the delegation and presented their ideas about necessary accents in the international exchange.

On almost 200 pages the reader provides an overview of the history and currency of the peace movement at the end of the 80s. In addition, it attempts to summarize the learning processes in the participating countries. In this manner it offers an exciting retrospective through the collected articles, essays and positions.

"Religious Fundamentalism and its Impact on Democratic Grassroots Movements" was the title of a program we conducted at the beginning of the 90s on the theme of fundamentalism. Part of the program was an exchange about fundamentalism, which was met at first with a great deal of skepticism. However, already during the preparation our own expectations had to be questioned and opinions altered. Under the assumption that there would be no denunciations of religious fundamentalism, the partners from the Centro Intereclesial de Estudios Teológicos y Sociales (CIEETS) in Nicaragua declared themselves ready to cooperate with the international delegation. On this basis, new impressions, experiences and knowledge became available. The hosts were not seen as a pure conglomerate of evangelical churches, but also as political actors in the revolutionary movement of Nicaragua.

The oil painting by Daniel Ortiz from Managua was created as part of the CIL-Workshop on "Religious Fundamentalism" in October 1992 in Nicaragua. People from the USA, from South Africa, from Germany, from the Philippines and from Nicaragua participated in this workshop. A small group of participants worked with the artist on their own ideas about fundamentalism and the experiences which they had made in the course of the workshop in various regions and fundamentalist communities in Nicaragua. The painting is the result of this work.





A Civilizing War – for the Disciplining of the 'New World'?

The positioning of the "International Working Group on Peace Politics" emerged from the discussion of various initiatives since the beginning of the war against Iraq, and is occupied with the relationships between destruction, ethics, and being human. The CIL appears as coauthor of the explicit position paper.




Sustainability—Solidarity and the Fetishes of Growth

Sustainability – the concept of sustainability is still being spoken about today. Whether a "sustainable business" or a "sustainable development", in almost all areas there is the requirement for this sustainability. Yet at the beginning of the 1990s the concept was far less self-evident. It had to be investigated, tested, and whatever further knowledge lay behind it had to be discovered.

In the work of the CIL the paradigm of Sustainability (UNCED-Conference, 1992) was broken down and studied. Whatdoes sustainability mean for us, how can we act in a sustainable manner and how can we live together sustainably? All of these questions were discussed in the following years. The practical work showed how many aspects could open up in the area of sustainability.


Themes of growth were discussed together; the voices of experts from the global South were heard and discovered, as to how human development could be shaped and (perhaps) have to change.

What do we communicate about ourselves and how should this happen? This question was already asked by the work group of the program "Parishes in Dialogue" in the summer of 1992. The compilation of 1996 opens up the perspectives on the answer from the Philippine side. Current problems and discussions are taken up, and it becomes clear that the question of sustainable living is closely connected with the needs of all human beings. The Christian Initiative International Learning acts on the interface of theory and lived praxis. Since its founding it has been developing and testing models for intercultural and international dialogue. At the center of the work is the meeting with other people and varying lived realities. Through its work the CIL opens up a space in which people from various parts of the planet, of varying ages, and with varying occupational and political experiences can experience and learn to know each other in learning workshops. In workshops the participants experience themselves as parts of international communication and are challenged with taking various perspectives, and to reflect on their own position in a global process. Working together in this way, models and visions of global and just living worlds come into being.

However, a part of the work is also the continual reflection on one's own methods and didactic approaches. In this way the learners learn not only through their experiences, but also through the learning processes in themselves. Many of these methods, reflections and didactic developments have been written down in publications and are available to support further learning processes.





Discovering worlds of work anew, observing altered situations with attention, substantiating alternatives, bringing theoretical considerations into dialogue with empirical developments were goals of the conference documented here. Participating in this dialogue about work, business start-ups and volunteer work were women from the city and the country from countries of the South and the North.

Human Right

Human right – the previous treatment of sustainability led eventually to the question of sustainable human development. This process of discovery continued in the thematic area of human rights. Being a sustainable human being, human rights and the right to being human, the extent to which these aspects of the area are interwoven was revealed by the events of the years at the beginning of the new millennium. Being a human being in old age and the relationship of the generations within a society assumed a prominent place. Young and old entered into conversation with each other, or experienced the perspective of the other through new impulses.

In this way human rights became tangible and were linked to people and histories which gave them a face.



Life perpectives of women in the third phase of life.

The last phase of the project, "Life perspectives for the period following occupation in job and family" are documented in this booklet. Definitions of work and thematic confrontations with the topic occupied the authors and finally led them to 10 recommendations.





Neighborhood — New Spaces and Friendships

Neighborhood – New neighborhoods were created through the eastward expansion of the EU. For the CIL this was also the time to discover new spaces and to engage in the work of reconciliation. In cooperation with various East European partners new projects and ideas were initiated, which emerged from the questions of sustainability and human rights. International dialogue on work, sense of community and justice led to new fields of work. Once again a new paradigm entered the CIL's field of vision, and with it a new task. Neighborhoods need encounters, need inclusion, and this became the new interface for the most current program of the CIL. With various new partners the assumed paradigm of "inclusion" meant finding and testing a didactic form of intercourse. Thus questions concerning one's own cooperation and communication came into focus.
